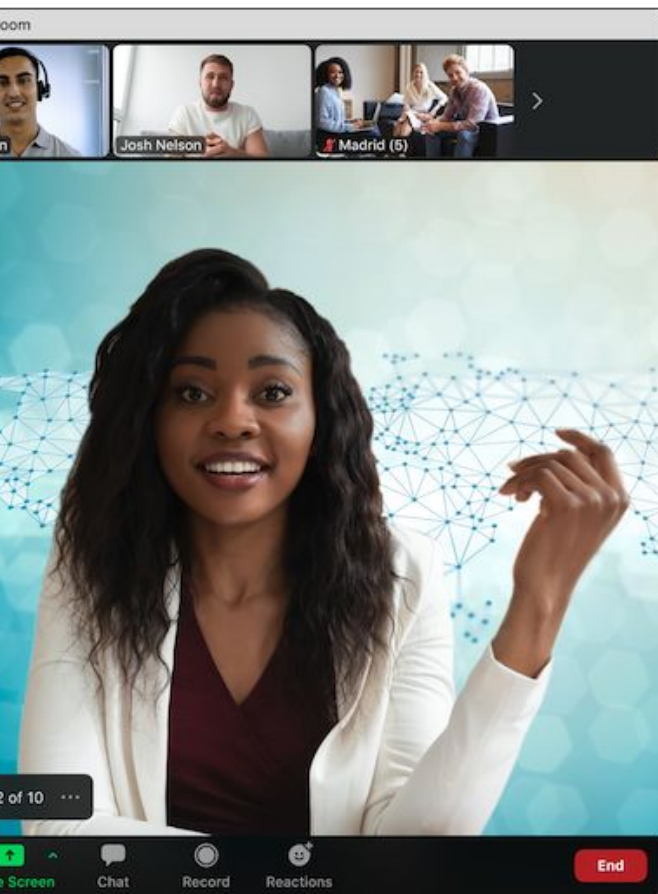

- Ensuring communications are established using 256-bit TLS encryption and all shared content can be encrypted using AES-256 encryption, and optional end-to-end encryption.
- Robust, and growing, meeting controls to easily let trusted participants into meetings; removing disruptive participants; and preventing potential disruptors from joining.
